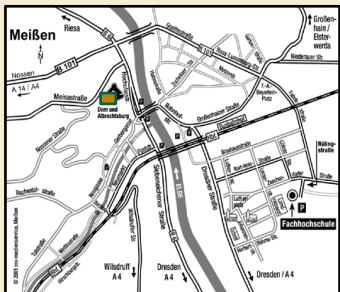

## Miasms: The cornerstone in Homoeopathic practice

The difference between ordinary and higher Homoeopathy, the pathway to step up a level higher – a breakthrough in clinical practice – a pathway to cracking more and more deeper pathologies in our practice – to solve those cases which have remained unsolved for a long time. Hahnemann has mentioned in his Chronic diseases that “the discovery of miasms is greater than the discovery of the law of Similia” ... such a big statement from the great Master. 15 years since the discovery of the truth of the law of Similia and Homoeopathy he still struggled with curing cases in his clinic – cure in the true sense i.e. going beyond giving symptomatic relief to patients.

His observations were that before the understanding of miasms:

1. Most of the cases used to improve nicely for a while and then relapse.
2. Disease would change its form but not get cured.
3. Desired cure was not achieved.

Are these also not the same observations that happen in our clinics??

The solution to this and improving the consistency and quality of results lies in the understanding of the miasms and its application in practice.

I would like to share my experience of the utility of miasms in

1. case taking
2. understanding and solving the cases
3. repertorisation
4. arriving at the remedy

5. posology ; potency selection and dosage
6. understanding followups

About understanding our remedies – all of us have a limited understanding of each medicine – what is popularly called as drug pictures, but are our drug pictures correct? Is the drug picture reflecting the whole understanding of the medicine?

Do we really know our medicines e.g. ignatia, natrum mur, sulphur, phos in their entirety? The answer is a big no!

We know only the tip of the iceberg – we miss these remedies when they present before us in a varied form from the prejudiced picture that we have in our mind – because medicines also behave differently in different individuals as per their miasm ... their scope of action varies

How? This can be understood through the understanding of trimiasmatic Materia medica!

What is trimiasmatic materia medica?

Understanding medicines through the prism of miasms – it is a very beautiful entertaining and enlightening journey – which I would like to share with you.
